## Deborah Ashenhurst, Ohio Dept. of Veterans Services

Deborah Ashenhurst (Maj. Gen. Ret.), is the new Director of the Ohio Department of Veterans Services.

Gen. Ashenhurst served in the Ohio Army National Guard for 37 years and has state cabinet-level experience as a former Adjutant General and commander of the state of Ohio.

She brings a wealth of military and private sector experience to the position as well as a developed connection to the veteran community. She has held assignments at all levels from company, battalion, brigade and Joint Force Headquarters.

Gen. Ashenhurst succeeded Col. Chip Tansill, who served as ODVS Director from September 21, 2015 until Jan. 13, 2019.

Gen. Ashenhurst is the first female director, the fifth overall and the highest ranking leader of the department since its inception in 2008. Her predecessors are the late William J. Hartnett (2008-11), Thomas N. Moe (2011-13), Timothy C. Gorrell (2013-15) and Tansill (2015-19).

Ashenhurst began her career in 1978 when she enlisted in the Ohio National Guard. She retired from the Army and the Guard in October 2015. Her career culminated in service as a special assistant to the vice chief, National Guard Bureau in Washington, D.C.

The Chairperson shall preserve order and call upon the Provost Marshal to assist the Chair. The Chairperson shall require observation of the rules of this conference and shall decide questions of order and procedure subject to a majority vote of delegates present.

The order of business shall be determined by the Chairperson and in accordance with the published agenda of this convention.

## **Committee Reports**

The Committee reports will not be presented to the convention orally. All reporting Chairpersons or their accredited substitutes will submit their respective reports on typewritten pages, made in triplicate to the convention for its approval.

## **Resolutions**

All resolutions to come before the conference must be submitted to the Resolutions Committee, which will in turn refer them to the proper committee for consideration and action.

All resolutions and petitions shall be typewritten and submitted to the Resolutions Committee in duplicate, in the proper resolution form and duly signed. Each committee shall give consideration only to resolutions, the subject matter of which pertains to the duties or functions of that particular committee. Resolutions which any particular committee does not consider its proper charge shall immediately be referred by such committee back to the Resolutions Committee for re-reference. A committee may originate such resolutions as it may desire pertaining to the subject with which such committee is charged. The agenda regarding the reporting of such resolutions shall be under supervision of the Resolutions Committee.

## **Debate**

Debate shall be limited to a reasonable time for each speaker. No more than three (3) speakers on each side of a question shall be permitted to speak upon the same subject except by unanimous consent of the delegates present. Total debate on any subject shall be limited to ¼ hour, however, debate on a resolution may be extended to a greater limit by majority vote of the delegates present and the time so allotted shall be evenly divided between the proponents and the opponents of the resolution who shall divide the allotted time among themselves.



### **Voting**

1. Post Commanders, State Elected Officers and Past State Commanders who are delegates to this conference will register with their Post delegation and their vote will be included in the Post delegation strength. The Department Commander shall vote only in the event of a tie.
2. Voting shall be by a voice or a standing vote, within the discretion of the presiding officer except when a roll call is ordered by the Chairperson presiding or upon the request of at least five (5) Posts, except that in the case of a vote on Constitutional amendments, one (1) Post may request a roll call vote and the roll call vote shall be ordered.
3. Elections shall be a roll call vote unless there is no contest.
4. Each Post delegation shall elect a permanent Chairperson who shall announce the vote of their delegation. When voting for a State District Commander, each Post is entitled to a maximum of five (5) votes. When the roll call of any Post delegation is demanded by a delegate thereof entitled to vote, the Chairperson of such delegation shall poll the vote of their delegation without debate or discussion on the questions being voted upon and shall announce the vote of the delegates, whether unanimous or divided.
5. Alternates cannot be substituted for an absent Post Commander, State Elected Officer or Past State Commander.
6. Unit rule and proxy voting will not be permitted.
7. Only votes of registered delegates and alternates present at time of voting will be cast. An alternate will vote only in the absence of a delegate.
8. The number of votes cast by a Post may be challenged by any delegate prior to the recognition of the next Post.

### **Elections**

Nominations shall be made from the floor on numerical roll call of Posts. Nominating speeches will be limited to two minutes each. No more than one seconding speech shall be made for any candidate. Elections shall be by a majority vote of the registered voting delegates at the convention. (A majority of the delegates seated and casting votes.)

No Post may change its vote within the same ballot after the next Post has been recognized. In voting, all candidates shall be kept in the contest for one (1) ballot, provided one is not elected on the first ballot. On the second ballot, the candidate receiving the lowest number of votes shall be eliminated from the ballot and on each succeeding ballot the candidate receiving the lowest number of votes shall be eliminated from the ballot until one is elected on one ballot. The remaining candidate shall then be declared elected by elimination of the other candidates.

### **Miscellaneous**

The State Provost Marshal shall be the Sergeant-at-Arms of the conference. The State Provost Marshal shall be assisted by assistant Provost Marshals as the State Provost Marshal may appoint with the approval of the Department Commander.

### **VAVS REPORT – J. Lori Stone, Youngstown Representative**

Commander, Delegates, and Guests:

I have been the AMVETS Representative for the Youngstown VA Community Based Outpatient Clinic (CBOC) since 2010 and I am honored to serve in this capacity. The clinic services 400 to 450 veterans each day. A number of these Veterans come from other CBOC's in the area, since our clinic does provide tests and special procedures that they are unable to be performed at those clinics. The Youngstown CBOC falls under Cleveland VA Hospital (Wade Park) and I do attend the required meetings. In March 2013, I was appointed by the Chief of the Cleveland VA Volunteer Services to fill the position of Volunteer Liaison for the Youngstown CBOC.

When I assumed the position I was asked to develop memorandums for the coffee cart and the food pantry that I oversee. This was one way to assure accountability for funds and to ensure procedures are in place that only Veterans in the VA hospital system receive the food bags.

The food pantry is open Wednesday and Thursday and the average number of bags given out per week is 120. FY 2018, a total of 5,934 bags were given out and 1,457 bags from Oct 1st to Dec 31st. The key to the program is the fantastic support received from the various organizations, churches, and individuals in the Tri-County area.

For an example: In honor of Veterans Day, the students of West Elementary School in Boardman, OH collected 1,300 lbs. of various food items. I have worked with the school for many years and they look forward to doing it. (Yes, the principal weights everything since it is a competition between classes.) There are standard items put in the bags and when there are food drives like this, individuals can select one extra item. This really does go over well. Working with the Wade Park Volunteer Service Liaison for the CBOC's, we developed the Youngstown schedule for CY 2019. This included quarterly meetings, along with the dates for the Volunteer Recognition Dinner and Annual Volunteers Picnic for the Veterans.

Areas the volunteers cover at the Youngstown CBOC are: reminder calls; coffee cart; lab desk; overseeing the book carts, preparation of food bags and distribution; van drivers and whatever else may need to be accomplished. For this reason, I developed work schedules for each area to ensure coverage. Shifts are from 7:00 AM to 11:00 AM or 11:00 AM to 3:00 PM. When required, I work in the various areas as well as pick-up the food, snacks and various items for the coffee cart. Recently the CBOC received a new cell phone charging station which was placed in a key location. On behalf of the staff and the patients, I would like to thank the Ohio AMVETS Charities. Your thoughtfulness is greatly appreciated!!!

I am very honored to have been reappointed to the Ohio War Orphans Scholarship Board through December 21, 2022 as the representative of AMVETS.

The Ohio War Orphans Scholarship Program awards tuition assistance to the children of deceased or severely disabled Ohio veterans who served in the armed forces during a period of declared war or conflict.

To receive War Orphans Scholarship benefits, a student must be an Ohio resident and enrolled for full-time undergraduate study and pursuing an associate or bachelor's degree at an eligible Ohio college or university. Applicants must apply between the ages of 16-24. Application deadline is May 15th each year. For more information you may contact Ramah Church at (614) 752-9528 or [rchurch@highered.ohio.gov](mailto:rchurch@highered.ohio.gov).

The Ohio War Orphans Scholarship Board met on July 26, 2018, to approve new applicants as well as funding levels for academic year 2018-2019.

It has been decided that students attending Public Institutions will be funded 84% of tuition and general fees, and students attending private institutions will receive an annual award amount of \$6,435 for the year. Students must attend full-time and prior recipients must meet appropriate cumulative GPA requirements (minimum 2.00).

## **POW / MIA COMMITTEE CHAIRMAN– Ted Ganda**

Commander Lowers, Officers, and Members:

As of November, 2018, 1,592 Americans are now listed by DoD as missing and unaccounted-for from the Vietnam War: Vietnam - 1,247 (VN-452, VS-795); Laos–290; Cambodia-48; Peoples Republic of China territorial waters–7. (These numbers fluctuate due to investigations resulting in changed locations of loss.)

We must seek the fullest possible accounting for those still missing and repatriation of all recoverable remains. Highest priority is accounting for Americans last known alive. US intelligence indicates some Americans known to be in captivity in Vietnam, Laos and Cambodia were not returned at the end of the war.

In the absence of evidence to the contrary, it must be assumed that these Americans could still be alive, and the US Government should not rule out that possibility. They must never lose sight of how important it is to find our POW/MIAs and return them to American soil. Whether they are alive or it is only their remains that return, their families deserve closure.

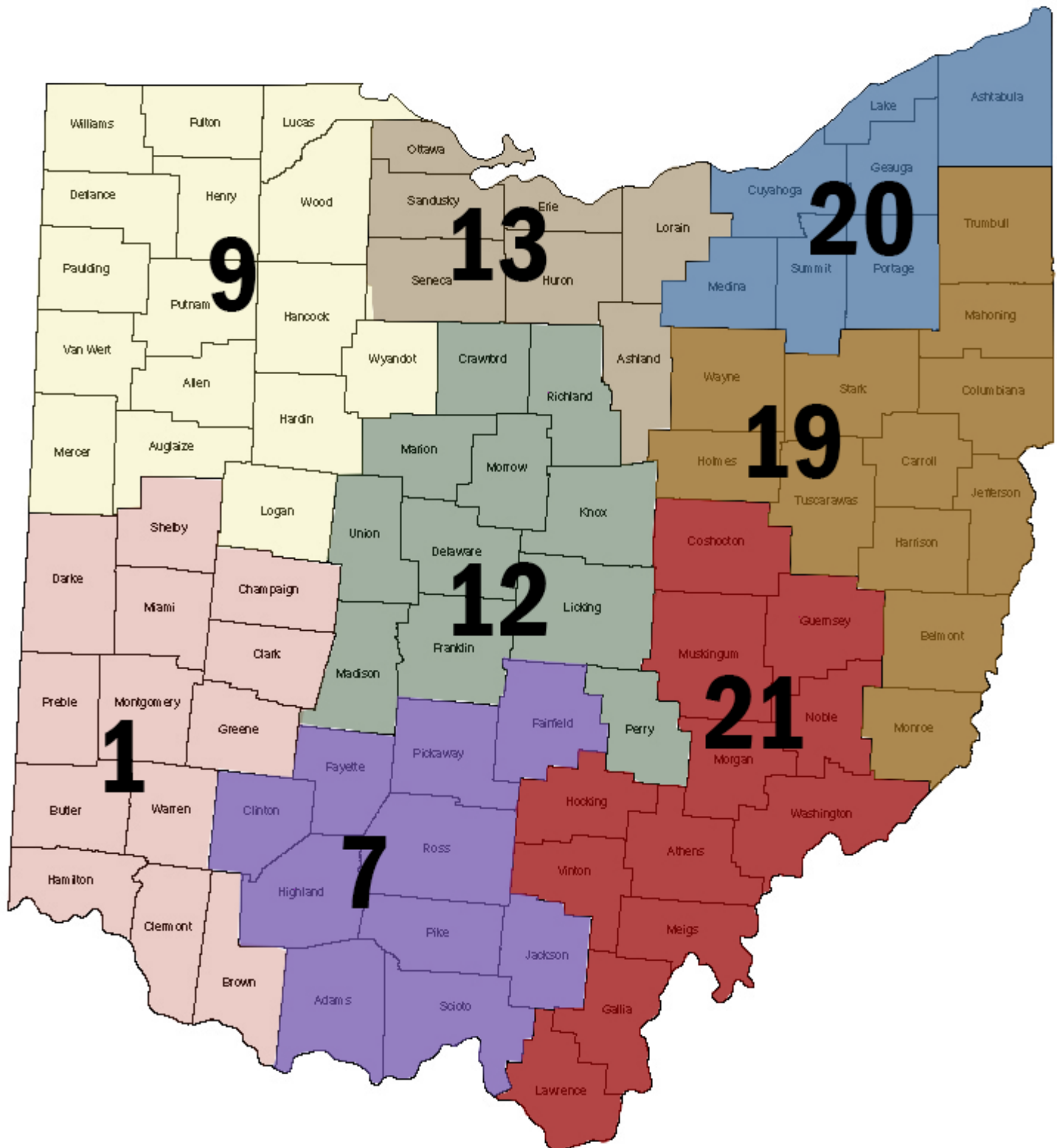
